The objective of this project is to:

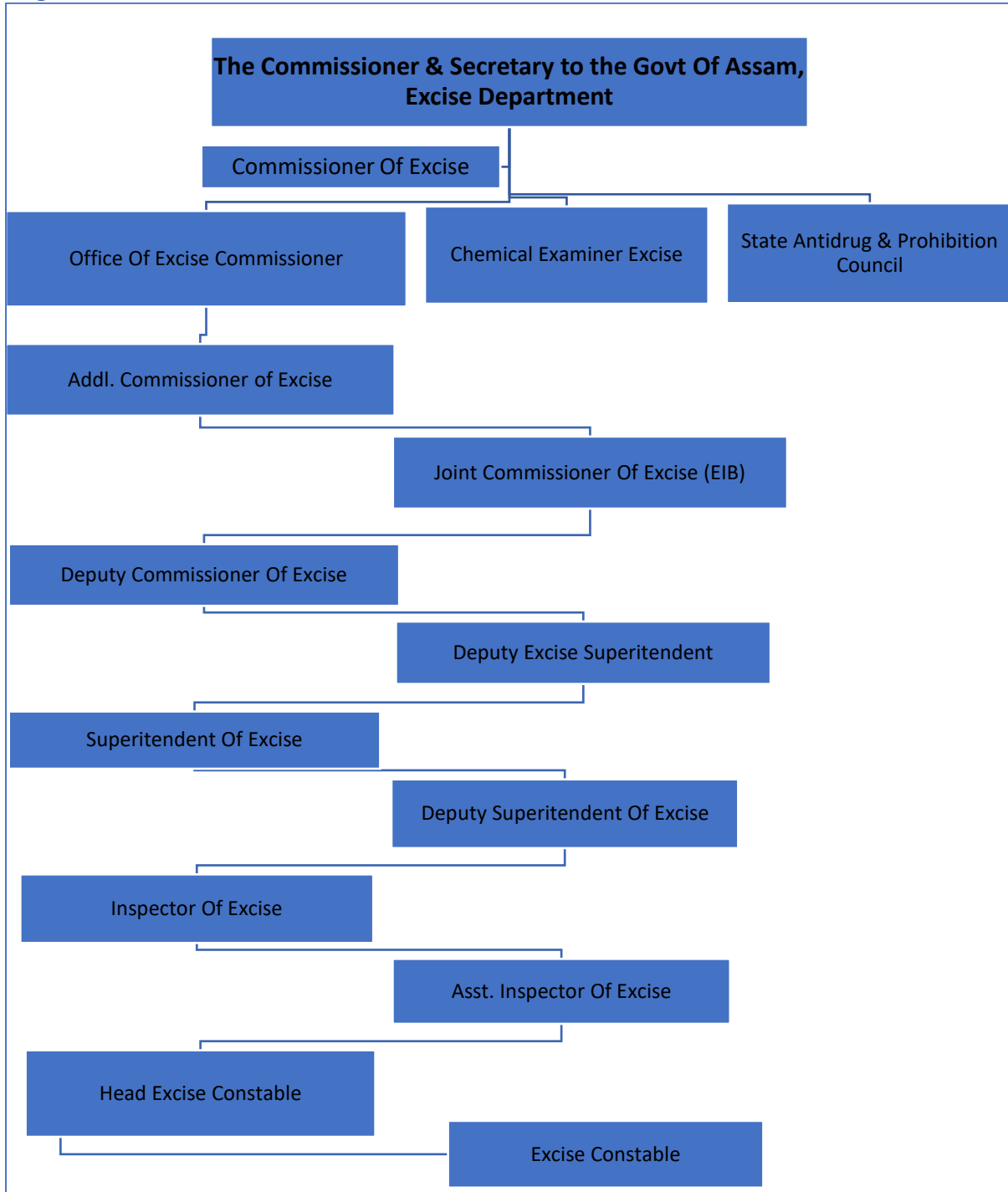
- ✦ Better Compliance Management

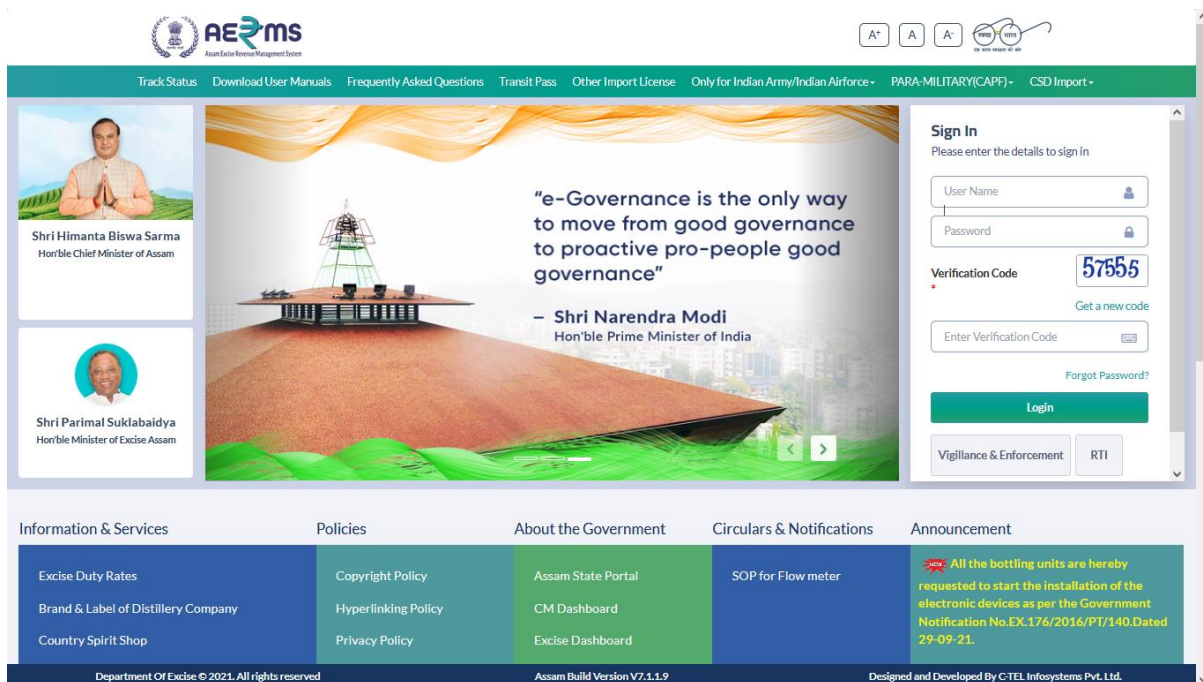


Figure 1: Assam Excise Revenue Management System Website

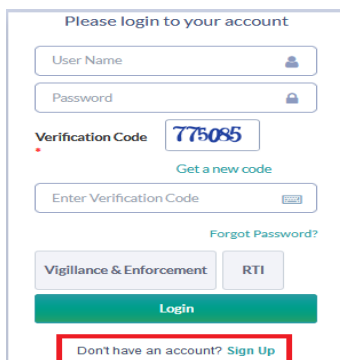


Figure 2: Sign Up

- Click on 'Login' to redirect to the Login page.

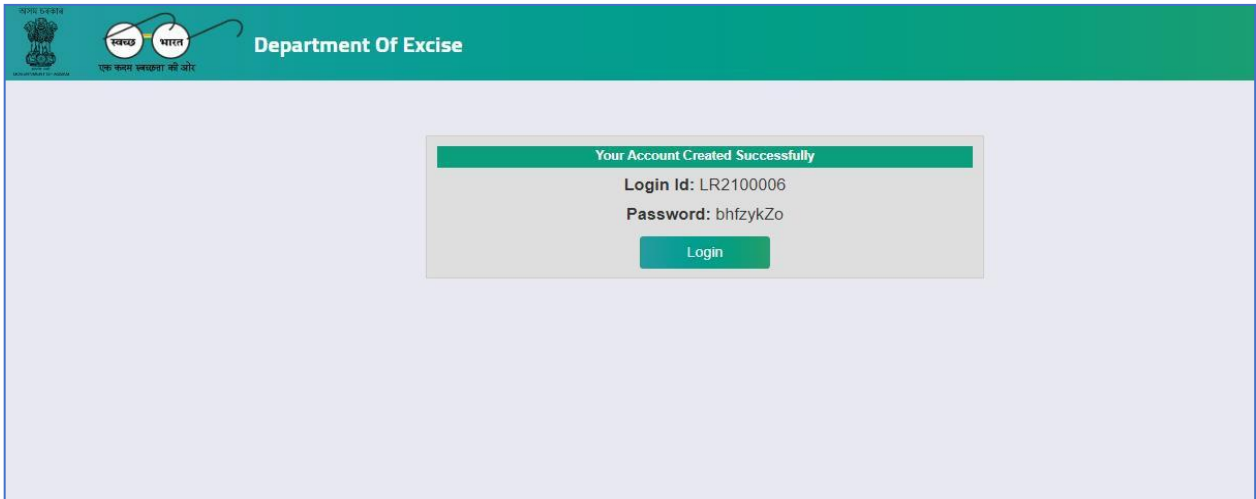


Figure 5: System Generated LR Number and Password

User is required to enter Login Id & Password & click on 'Sign In' button to login

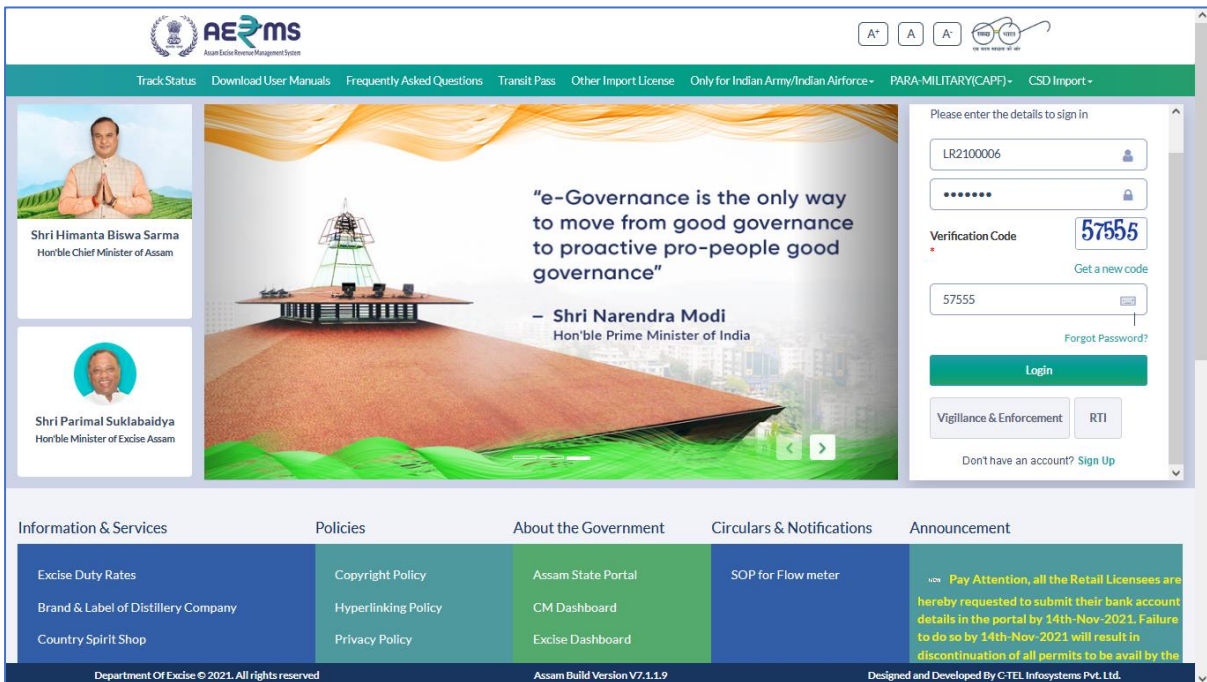


Figure 6: Login Page

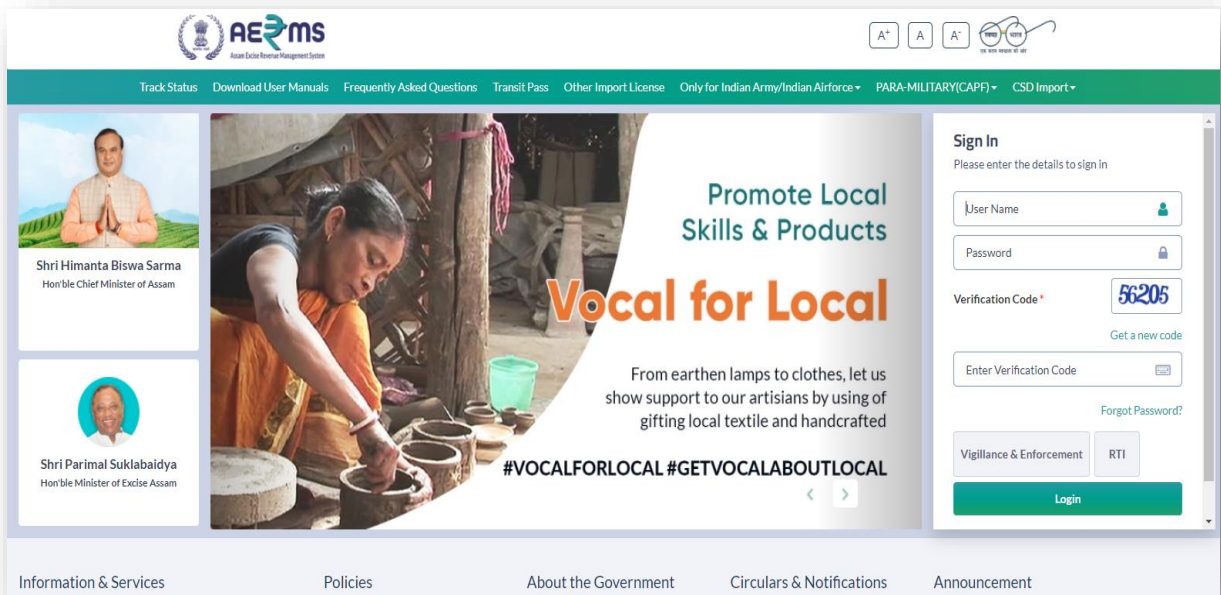

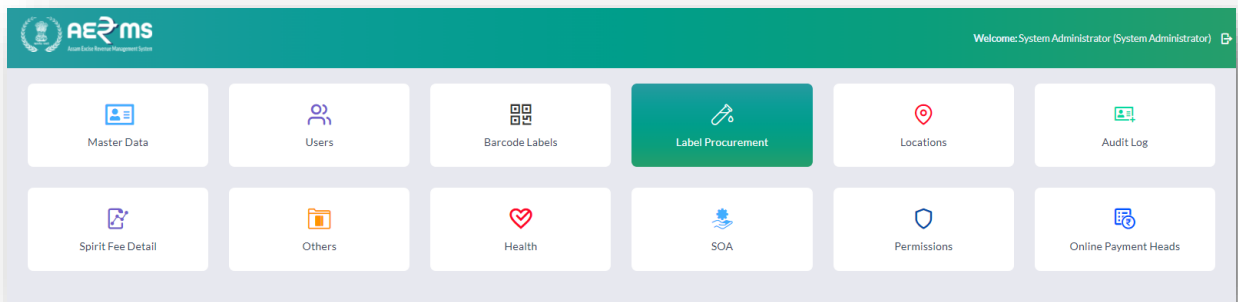
ADMIN LOGIN

 4. Entering generated verification Captcha

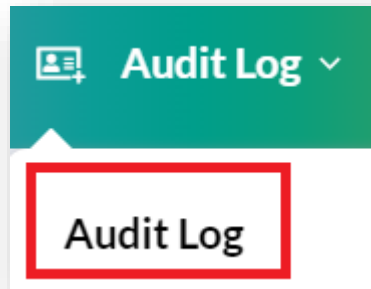
Click on the Login button to advance to the next screen
